Privacy Policy

Your privacy is important to Sayso Ltd ("Sayso"). It is Sayso's policy to respect your privacy regarding any information Sayso or any of its contractors, suppliers or partners may collect from you in the course of using Website or ordering or performing services available at or through Website, including production by Sayso of testimonial videos (the "Services").

Please read the Agreement and this Privacy Policy carefully before further using Website or ordering Services. By accessing and using Website or by ordering Services, you agree to become bound by the terms and conditions of the Agreement including this Privacy Policy. - 1. <u>Information we collect</u>. When you visit Website, our servers may automatically log the standard data provided by your web browser. It may include your computer's Internet Protocol (IP) address, your browser type and version, the pages you visit, the time and date of your visit, the time spent on each page and other details. We may also collect data about the device you're using to access Website. What we collect can depend on the individual settings of your device and software.
